On January 10, 2019, Hexion Inc. (the “Company”) announced that Joseph P. His departure is part of a plan to reorganize the Company into a leaner reporting structure. Mr. Bevilaqua’s duties will be assumed by other members of the Company’s senior management following his departure.
